






THE



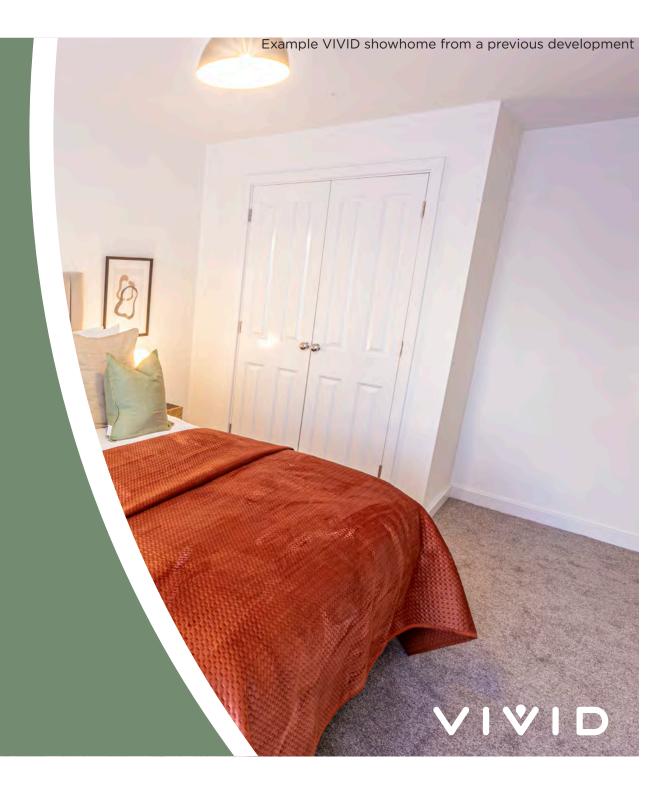


