Summary of costs

When you buy a home through shared ownership, you enter into a shared ownership lease. The lease is a legal agreement between you (the 'leaseholder') and the landlord. It sets out the rights and responsibilities of both parties.

Before committing to buy a shared ownership property, you should ensure you take independent legal and financial advice.

This summary of costs document is to help you decide if shared ownership is right for you. You should read this document carefully so that you understand what you are buying, and then keep it safe for future reference.

It does not form part of the lease. You should carefully consider the information and the accompanying lease, and discuss any issues with your solicitor before signing the lease.

Failure to pay your rent or service charge or your mortgage could mean your house is at risk of repossession.

Examples and figures provided in this summary of costs document are correct at the time of issue but will change over time in accordance with changes in house prices and the terms of the shared ownership lease.

The monthly payments to the landlord will be reviewed annually. The figures in this document will only apply to the first year of the lease.

Rent	If you buy a 25% share, the rent will be £506.88 a month.
	The percentage share and rent amount is based on the amount you can afford.

	You'll need to budget for your other costs of owning a home, which are not included in the monthly payment to the landlord. For example, mortgage repayment, contents insurance, Council Tax, gas and electricity, and water.

Rent review

Rent review period	Your rent will be reviewed every year on 31 st March.
Rent increase	The maximum amount your rent can go up by is the same as the percentage increase in the <u>Retail Prices Index</u> (RPI) for the previous 12 months plus 0.5%.

Future costs if you buy more shares

Home valuation	If you choose to buy shares of 5% or more, you'll need to pay for a valuation by a surveyor who is registered with the <u>Royal Institution of Chartered Surveyors</u> (RICS). The estimated current cost is £260 inc VAT.
	You will need to arrange the valuation – if you instruct from our panel quoting 'Latimer' the fee is as above. If you choose a valuer off panel then it will be variable.
	You can find a registered surveyor on the RICS website.
	The price of a 1% share is based on the original full market value adjusted up or down each year in line with the <u>House</u> <u>Price Index (HPI)</u> . You'll receive an HPI valuation at least once a year. You or the landlord can choose to use a RICS valuation instead of HPI. The party who chooses to instruct a RICS surveyor pays for the cost of the valuation.

Share purchase admin fees	Buy shares of 1% - no admin fee.
lees	Buy shares of 5% or more - £250 up to 100%. £500 on final staircasing (fees inclusive of VAT)
	You cannot buy shares of 2%, 3% or 4%.
Your solicitors' fees	Where you require legal advice when buying more shares, you are responsible for paying your own legal fees. Your mortgage lender will require you to instruct a solicitor if you are borrowing money to fund any purchase of additional shares. The landlord is responsible for paying their own legal fees related to share purchase transactions.

Future costs if you sell your home

Landlord's current selling fee	The current charge is 1.5% plus VAT of the value of the share sold – up to 1% plus VAT of the market value. NB this fee is payable if a buyer is found by us or our appointed agent in the nomination period. If using an agent the below will apply
Landlord admin fee	£180 (Inc VAT)
Our solicitors fee	£420 (inc VAT)

Leasehold pack	When you sell you'll need to purchase a leasehold pack for your buyer. This is currently charged at $\pounds180$ (inc VAT) for a house and $\pounds300$ (inc VAT) for an apartment
Estate agent's fee	You'll need to pay their fee, which is negotiable.
Your solicitors' fees	You are responsible for seeking legal advice when you sell your home. You will need to pay your legal fees.
Home valuation	The landlord arranges the valuation by a surveyor who is registered with the Royal Institution of Chartered Surveyors (RICS). You are responsible for paying the cost.
