

## Summary of costs

The information in this document is for the **standard shared ownership model**. There are variations of shared ownership which have different features. For more information on the variations, see the 'Key information about the home' document.

When you are looking for shared ownership homes, you should always check the Key Information Document to see which model covers that specific home.

When you buy a home through shared ownership, you enter into a shared ownership lease. The lease is a legal agreement between you (the 'leaseholder') and the landlord. It sets out the rights and responsibilities of both parties.

Before committing to buy a shared ownership property, you should take independent legal and financial advice.

This summary of costs document is to help you decide if shared ownership is right for you. You should read this document carefully so that you understand what you are buying, and then keep it safe for future reference.

It does not form part of the lease. You should carefully consider the information and the accompanying lease and discuss any issues with your legal adviser before signing the lease.

Failure to pay your rent, service charge, or mortgage could mean your home is at risk of repossession.

The costs in this document are the costs as at the date issued. These will increase (typically on an annual basis) and you should take financial advice on whether this will be sustainable for you.

## Purchase costs

<b>Full market value</b>	£285,000
<b>Share purchase price</b>	£142,500 (50% share)  The share purchase price and percentage are based on the amount you can afford.
<b>Deposit</b>	Minimum £7,125 (5% of the sale purchase price)  The deposit is payable when you exchange contracts to buy the home. It will be taken off of the final amount you pay on completion. For more information, speak to your legal adviser.
<b>Reservation fee</b>	£300
<b>Your solicitors' fees</b>	Solicitors' fees can vary. You can expect to pay fees including: <ul style="list-style-type: none"><li>• legal services fee</li><li>• search costs</li><li>• banking charges</li><li>• Land Registry fee</li><li>• document pack fee</li><li>• management agent consent fee - subject to development and terms of the management company</li></ul> You'll need to ask your solicitor what the fees cover and the cost for your purchase.
<b>Stamp Duty Land Tax (SDLT)</b>	You may have to pay Stamp Duty Land Tax (SDLT) depending on your circumstances and the home's market value. Discuss this with your solicitor. ## Your monthly payments to the landlord

<b>Rent</b>	<p>If you buy a 50% share, the rent will be £370.83 a month.</p> <p>The percentage share and rent amount is based on the amount you can afford.</p>
<b>Service charge</b>	<p>£39.52 a month.</p> <p>The service charge applies to the communal parts of the estate and the leaseholders will incur these charges in addition to the costs of maintaining their own flat. The service charge may also include annual contributions to a reserve fund, which is service charge money set aside to help cover the costs of major works. Service charges must be paid to ensure that the landlord or managers have sufficient funds to provide all of the services and maintenance needed for the effective management of the property.</p> <p>Southern Housing are signed up to the GLA's Service Charges Charter.</p>
<b>Estate charge</b>	<p>There is no estate charge to pay.</p>
<b>External Management Company</b>	<p>£100.93 a month</p> <p>An External Managing Agent provides some of the communal services for the estate and insures the building. Details of the Managing Agent will be supplied within the LPE1 Management Pack following the successful reservation of an Applicant.</p>
<b>Buildings insurance</b>	<p>The Building Insurance is collected by the External Management Company. Details of the building insurance policy will need to be requested by a successful Applicant alongside the LPE1 Management Pack.</p>

<b>Management fee</b>	<p>£26.15 a month</p> <p>The management fee is payable to Southern Housing Group Limited.</p> <p>The management fee is part of the service charge payable to the landlord or manager in return for managing the leasehold property. This fee is the only part of the service charge that goes directly to the landlord or manager and the remaining income received is for the cost of services, repairs, maintenance, improvements, insurance or set aside as a reserve fund. Management fees or similar charges can only be recovered from leaseholders if a term in the lease specifically allows for this.</p>
<b>Reserve (sinking) fund payment</b>	<p>£15.24 a month</p>
<b>Total monthly payment to the landlord</b>	<p>Your total monthly payment for the rent and other charges described above will be:</p> <p>£552.67 a month</p> <p>You'll need to budget for your other costs of owning a home, which are not included in the monthly payment to the landlord. For example, mortgage repayment, contents insurance, Council Tax, gas and electricity, and water.</p>

## Rent review

<b>Rent review period</b>	<p>Your rent will be reviewed every year in February commencing from the 1<sup>st</sup> April each year.</p>
<b>Rent increase</b>	<p>The maximum amount your rent can go up by is the same as the percentage increase in the <a href="#">Retail Prices Index</a> (RPI) for the previous 12 months plus 0.5%.</p> <p>Your landlord will notify you each year what this amount will be and tell you the date from which the new rent will be payable.</p> <p>Your rent will go up when it is reviewed. It will never go down.</p> <p><b>Example rent increases</b></p>

The examples below show how your rent could rise based on an RPI percentage increase of 3%, 6% and 9%. These are illustrations only and the actual RPI for the relevant year will be used to calculate your rent increases.

Initial rent	Example RPI increase percentage	Applied percentage increase (RPI plus 0.5%)	Example new monthly rent
£552.67	3%	3.5%	£572.01
£552.67	6%	6.5%	£588.59
£552.67	9%	9.5%	£605.17

## Future costs if you buy more shares

<p><b>Home valuation</b></p>	<p>If you choose to buy shares of 10% or more, you'll need to pay in full for a valuation by a surveyor who is registered with the <a href="#">Royal Institution of Chartered Surveyors (RICS)</a>. The estimated current cost is £180 - £330 Inc VAT</p> <p>You will need to arrange the valuation.</p> <p>You can <a href="#">find a registered surveyor on the RICS website</a>.</p> <p>For more information, see section 6, 'Buying more shares', in the 'Key information about shared ownership' document.</p>
<p><b>Share purchase administration fees</b></p>	<p>Buy shares of 10% or more - £200.00 + VAT (£240.00)</p>
<p><b>Your legal adviser's fees</b></p>	<p>If you require legal advice when buying more shares, you are responsible for paying your own legal fees.</p> <p>Regardless of whether you require legal advice, it is likely that your mortgage lender will require you to instruct a suitably qualified legal adviser if you are borrowing money to fund any purchase of additional shares.</p> <p>The landlord is responsible for paying their own legal fees related to share purchase transactions.</p>

## Future costs if you sell your home

<b>Landlord's current selling fee</b>	1%+VAT of the market value  Your landlord may charge a fee for marketing and finding a buyer for your home when you sell. If they do not find a buyer, this will not apply.
<b>Estate agent's fee</b>	You will only pay this if you use an estate agent. You can usually negotiate their fee. You can normally only choose to use an estate agent when the Landlord's nomination period has ended. See the 'Landlord's nomination period' section of the 'Key information about your home' document for more information.
<b>Your legal adviser's fees</b>	You are responsible for seeking legal advice when you sell your home. You will need to pay your legal fees.
<b>Home valuation</b>	You will arrange the valuation from a surveyor who is registered with the Royal Institution of Chartered Surveyors (RICS). You are responsible for paying the cost.

## Future costs if you need to extend your lease term

All shared ownership homes are sold as leasehold, even houses. You may need to extend the term of your lease. This is because a short lease can affect the value of your home and can make it more difficult to sell or get a mortgage on the home. A short lease is generally considered as one with 80 years or less left on the term, although different lenders have different criteria. It can be significantly more expensive to extend a short lease.

<b>Lease term</b>	106 years
<b>Maximum share you can own</b>	You can buy up to 100% of your home.

Shared owners who own less than 100% of their home do not currently have a legal right to extend their lease term. Your landlord will confirm their policy on lease extensions for shared owners including how they apportion costs.

### Enforcement of covenants

Where Southern Housing are requested to enforce covenants (i.e. action beyond initial contact and advice of alleged breach) against other leaseholder/s for suspected breaches which Southern Housing do not consider it reasonable or appropriate to pursue, Southern Housing will charge an hourly fee for any work associated to those making the request. Any costs for legal advice/work and any other costs or fees incurred must also be covered.

£25 (per hr) plus all other fees, costs and charges incurred

### Undertaking Tenant covenants (Stepping in)

Where Southern Housing must step in to action a tenant covenant which is not performed, admin will be charged per hour (minimum half day charge), plus any costs, fees or other charges incurred.

£25.00 (per hr) 20% £30.00

Where Southern Housing is requested to undertake a repair which is the leaseholder's responsibility, admin will be charged per hour (minimum half day charge), plus any costs, fees or other charges incurred.
