The generously-sized apartment is on the eighth floor and features a spacious reception room with wood flooring, open-plan kitchen, full-height windows and a door that leads out onto the south/south-west-facing balcony. The bathroom is stylish and modern with premium fittings and the apartment includes a pair of storage/utility cupboards. Elmbridge House is part of a recently-built development in the Nine Elms Regeneration Area. Demanding insulation standards, high performance glazing and underfloor heating fed from a communal hot water system make for a very good energy-efficiency rating. Battersea Park is only a few minutes away, offering a lake, sports facilities and large open spaces. Battersea Park Station and Queenstown Road are close and the redeveloped Battersea Power Station site provides restaurants, bars and stores as well as a new Northern Line station. Food shopping is convenient with Waitrose and Sainsbury's supermarkets in the local area and nearby Chelsea Bridge also means areas north of the Thames are in easy reach.

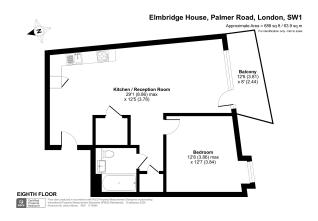

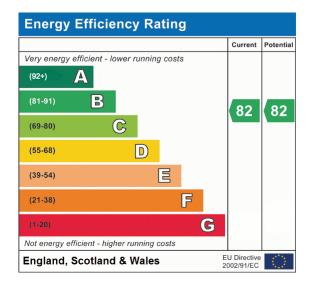

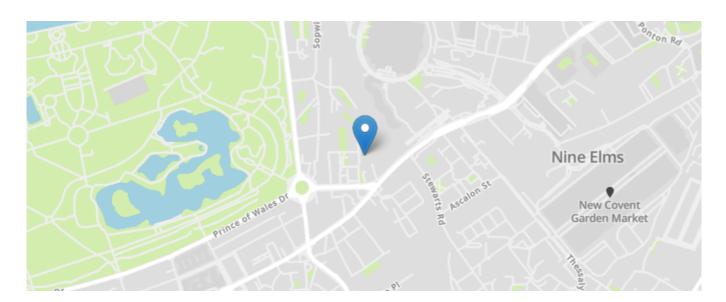
