


Properties can be let if they have an energy rating from A to E.

Energy rating and score

How this affects your energy bills

An average household would need to spend £1,463 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

- 9,486 kWh per year for heating
