GENERAL DESCRIPTION

SHARED OWNERSHIP (Advertised price represents 35% share. Full market value £355,000). A rare chance to buy a coach house in this popular location. The property forms the upper floor of a detached and recently-constructed building. Access is via a private entrance with stairs leading up to a naturally-lit hallway. There is a twenty-two-foot reception room with east/south-east-facing Juliette balcony and a semiopen-plan kitchen area featuring sleek units and integrated appliances. The spacious main bedroom has an en-suite shower room, the second bedroom is a good-sized double and the bathroom is simple yet stylish. Well insulated walls, roof and floor, high performance glazing and a modern gas central heating system all contribute towards a very good energy-efficiency rating. the car port nearest the front door is demised to this property and includes a storage cupboard at the rear. There is space to park an additional car in front. Alternatively, the Swanscombe and Ebbsfleet railway stations can both be reached on foot or by brief cycle ride. Nearby Cherry Orchard Primary School is Ofsted-rated 'Outstanding'.






