




THE LOCATION


Cupernham Infant and Junior School is close by, there is also Abbotswood Pre-School and nursey in close vicinity too. The Romsey School is the closest for older children.




Plot 2 3 BEDROOM HOUSE








Plot 2 SIDE ELEVATION






