The semi-detached property has a cloakroom/WC just off the entrance hall, a kitchen/dining room with bay window and a reception room at the rear. Patio doors open onto a neatly-kept, south-east-facing garden which can also be accessed via the side gate. On the first floor of the house is a large main bedroom with en-suite shower room plus a second double bedroom and a naturally-lit bathroom with limestone-style tiles. Well insulated walls, roof and floor, high performance glazing and a modern gas central heating system all contribute towards a very good energy-efficiency rating. The house comes with a two-car driveway and is located approximately six miles to the north of Norwich city centre. Ofsted-list five primary schools within a two-mile radius, all rated 'Good'. Very long lease (freehold transferred on 100% ownership).




