This recently-constructed, semi-detached property has a reception room with open staircase and a combined feature fireplace/TV unit. A door leads through to a large kitchen/dining room with sleek, white units and contrasting splashbacks. There is also a utility room and a ground-floor cloakroom/WC. On the first floor of the house is a main bedroom with fitted wardrobe and en-suite shower room plus a spacious second double bedroom, a smaller third bedroom and a naturally-lit bathroom. Well insulated walls, roof and floor, high performance glazing and a modern gas central heating system all contribute towards a very good energy-efficiency rating. The property comes with a two-car driveway and a good-sized, west/south-west-facing rear garden with patio, lawn and timber shed. Nearby Havenstoke Park offers beautiful outside space to enjoy and the city centre is within easy reach. The three closest primary schools are Ofsted-rated 'Good' and there are several other well-thought-of schools in the surrounding area.

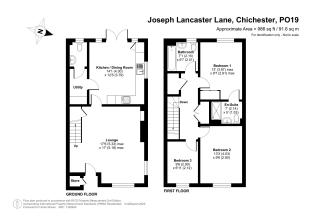

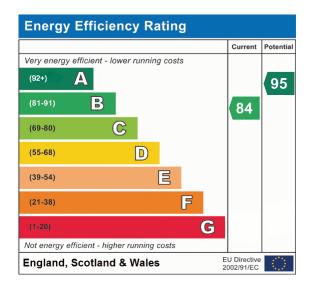

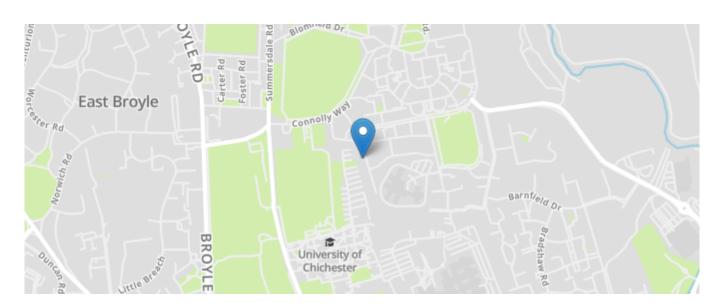
