## GENERAL DESCRIPTION

SHARED OWNERSHIP (Advertised price represents 40% share. Full market value £350,000). A spacious apartment on the top floor of this recently-constructed development. The property has an approximately twenty-three-foot reception room with attractive, open-plan kitchen area featuring handle-less units and integrated appliances. A door leads out onto an east/south-east-facing balcony. The generously-sized main bedroom has a fitted wardrobe and en-suite shower room. There is a second, comfortable, double bedroom, a simple yet stylish bathroom and a large hallway storage/utility cupboard. Modern insulation standards, high performance glazing and a communal heating and hot water system have resulted in a very good energy-efficiency rating. This particular apartment comes with the use of two parking spaces, one above ground and one in the gated, underground car park. Alternatively, Ashford Railway Station, for services between Weybridge/Windsor & Eton Riverside and London Waterloo, is only a short walk away.




