

## Key information about the home

When you buy a home through shared ownership, you enter into a shared ownership lease. The lease is a legal agreement between you (the 'leaseholder') and the landlord. It sets out the rights and responsibilities of both parties.

Before committing to buy a shared ownership property, you should ensure you take independent legal and financial advice.

This key information document is to help you decide if shared ownership is right for you. You should read this document carefully so that you understand what you are buying, and then keep it safe for future reference.

It does not form part of the lease. You should carefully consider the information and the accompanying lease, and discuss any issues with your solicitor before signing the lease.

Failure to pay your rent or service charge or your mortgage could mean your house is at risk of repossession.

Examples and figures provided in this key information document are correct at the time of issue but will change over time in accordance with changes in house prices and the terms of the shared ownership lease.

<b>Share purchase price</b>	<p>£105,000 (30% share)</p> <p>The share purchase price offered to you will be based on an assessment of what you can afford.</p>																					
<b>Rent</b>	<p>The share purchase price is calculated using the full market value and the percentage share purchased.</p> <p>If you buy a 30% share, the share purchase price will be £105,000 and the rent will be £849.33 a month.</p> <p>If you buy a larger share, you'll pay less rent. <b>Eligibility</b>	<p>To assess your eligibility, you'll need to register with a Help to Buy agent.</p> <p>You can apply to buy the home if both of the following apply:</p> <ul data-bbox="523 875 1414 1388" style="list-style-type: none"> <li>• your gross household income is £90,000 or less</li> <li>• you cannot afford all of the deposit and mortgage payments to buy a home that meets your needs</li> <li>• One of the following must also be true: <ul data-bbox="523 1111 1414 1388" style="list-style-type: none"> <li>• you're a first-time buyer</li> <li>• you used to own a home but cannot afford to buy one now</li> <li>• you're forming a new household - for example, after a relationship breakdown</li> <li>• you're an existing shared owner, and you want to move</li> <li>• you own a home and want to move but cannot afford a new home for your needs</li> </ul> </li> </ul> <p>If you own a home, you must have completed the sale of the home on or before the date you complete your shared ownership purchase.</p> <p>You must have a good credit record. Your application will involve an assessment of your finances.</p>

<b>Maximum share you can own</b>	You can buy up to 100% of your home.														

<b>Transfer of freehold</b>	At 100% ownership, the leasehold title remains in your name but your shared ownership obligations fall away
<b>Landlord</b>	<p>L&amp;Q 29-35 West Ham Lane Stratford, London, E15 4PH</p> <p>Under a shared ownership lease, you pay for a percentage share of the market value of a home. You enter into a lease agreement with the landlord, and agree to pay rent to the landlord on the remaining share.</p>
<b>Landlord's first option to buy</b>	When you give the landlord notice that you intend to sell your share in your home, the landlord has 8 weeks to find a buyer. (The landlord may offer to buy back your share, but only in exceptional circumstances and if they have funds available.) If they do not find a buyer within 8 weeks, you can sell your share yourself on the open market. For example, through an estate agent.
<b>Pets</b>	<p>You cannot keep pets at the home. [Supplied by the Managing agent for the freeholder]</p> <p>From the Head lease 20 Pets</p> <p>20.1 Not to keep or permit any bird or animal or reptile in the apartment without written permission of the Landlord which if given shall be deemed to be by way of licence revocable by the Landlord at will (save that this covenant does not prevent the keeping of a dog used as a guide or hearing dog or dog for the disabled)</p> <p>20.2 Not to permit pets to play or bark in the common parts so as to cause a nuisance or disturbance to any other occupier of the Plot of Estate.</p>
<b>Subletting</b>	<p>You can rent out a room in the home, but you must live there at the same time.</p> <p>You cannot sublet (rent out) your entire home unless you either:</p> <ul style="list-style-type: none"> <li>• own a 100% share: or</li> <li>• have your landlord's permission which they will only give in exceptional circumstances (see section 1.5 in 'Key information about shared ownership' document)</li> <li>• and</li> <li>• have your mortgage lender's permission if you have a mortgage</li> </ul>
