## Key information about the home

There are variations of shared ownership models which have different features. The model of shared ownership may vary depending on:

- what rules were in place at the time the home was funded or planning permission granted
- where the home is located
- whether the home is for a specific group of people

The table below highlights the key features of common shared ownership schemes. The information in this document is for the **new model shared ownership**.

When you are looking for shared ownership homes, you should always check the Key Information Document to see which model covers that specific home.

When you buy a home through shared ownership, you enter into a shared ownership lease. The lease is a legal agreement between you (the 'leaseholder') and the landlord. It sets out the rights and responsibilities of both parties.

Before committing to buy a shared ownership property, you should take independent legal and financial advice.

This key information document is to help you decide if shared ownership is right for you. You should read this document carefully so that you understand what you are buying, and then keep it safe for future reference. This document 'Key information about the home' is a summary and you should consider the information in 'Summary of costs' and 'Guide to shared ownership' before making a decision.

This does not form part of the lease. You should carefully consider the information and the accompanying lease and discuss any issues with your legal adviser before signing the lease.

Failure to pay your rent, service charge, or mortgage could mean your home is at risk of repossession.

The costs in this document are the costs as at the date issued. These will increase (typically on an annual basis) and you should take financial advice on whether this will be sustainable for you.

<p><b>Reservation fee</b></p>	<p>£250.</p> <p>You'll need to pay a reservation fee to secure your home. When you pay the fee, no one else will be able to reserve the home.</p> <p>If you buy the home, the fee will be taken off the final amount you pay on completion. If you do not buy the home, the fee is not refundable.</p>
<p><b>Eligibility assessment</b></p>	<p>The housing provider will assess whether you meet the eligibility criteria for the scheme.</p> <p>This will be based on the eligibility criteria for the shared ownership scheme and the housing provider's specific policies. 	<p>If you own a home, you must have completed the sale of the home on or before the date you complete your shared ownership purchase.</p> <p>As part of your application, your finances and credit history will be assessed to ensure that you can afford and sustain the rental and mortgage payments.</p>
<b>Affordability assessment</b>	<p>You will be assessed to check you can afford the home.</p> <p>Your affordability assessment will be carried out by a suitably qualified and experienced adviser.</p> <p>As part of the affordability assessment, you will need to provide documents to confirm your income, savings, and financial commitments.</p> <p>The assessment will take into account the housing provider's specific policies including:</p> <ul style="list-style-type: none"> <li>📄 The minimum requirements for your credit history - <a href="#">Aster Group Adverse Credit Policy.pdf</a></li> <li>📄 The amount of money you have surplus if you were to purchase the home - <a href="#">Aster Group Surplus Income.pdf</a></li> </ul>

<b>Rent review</b>	<p>Your rent will be reviewed each year by a set formula using the Retail Prices Index (RPI) for the previous 12 months plus 0.50%.</p> <p>For more information, see the Rent Review section in the 'Summary of Costs' document which includes an example of how rent could increase over a 5 year period. A worked example demonstrating how the rent is calculated at review is also set out in Appendix 2 of the lease.</p>

<b>Maximum share you can own</b>	You can buy up to 100% of your home.
<b>Transfer of freehold</b>	At 100% ownership, the freehold will transfer to you
<b>Landlord</b>	<p>Aster Group Sarsen Court Horton Avenue, Cannings Hill Devizes Wiltshire SN10 2AZ</p> <p>Under a shared ownership lease, you pay for a percentage share of the market value of a home. You enter into a lease agreement with the landlord and agree to pay rent to the landlord on the remaining share.</p>
<b>Initial repair period</b>	<p>Up to £500 a year for the first 10 years to help with essential repairs. <b>Landlord's nomination period</b>	<p>When you give the landlord notice that you intend to sell your share in your home, the landlord usually has 4 weeks to find a buyer.</p> <p>The landlord may offer to buy back your share, but only in exceptional circumstances and if they have funds available. If they do not find a buyer within 4 weeks, you can sell your share yourself on the open market. For example, through an estate agent.</p> <p>The landlord may decide to waive their rights to the nomination period (either from the outset or during the existing nomination period). <b>Pets</b>	<p>You can keep pets at the home. All permissions must be sought prior to occupation.</p>
<b>Subletting</b>	You can rent out a room in the home, but you must live there at the same time.

You cannot sublet (rent out) your entire home unless you either:

- own a 100% share; or
- have your landlord's permission which they will only give in exceptional circumstances (see section 1.5 in 'Key information about shared ownership' document)

and

- have your mortgage lender's permission if you have a mortgage
